
Column 1	Counter	- This is the short form of the name of the company whose security is listed

Column 4	Sale	- This is the price at which the security was traded.
Column 5	Volume	- This is the number of securities that were traded during the day.
Column 6	Turnover	- This is the value of securities that were traded during the day.
Column 7	Weighted Price	- This is the volume weighted average price for the securities of the firm using the last five daily trades on.
Column 8	Securities Issued	- This is the total number of securities that have been issued by the firm and are available to the public for trading.
Column 9	Market Capitalisation	- This is the total value of the company that accrues to the holders / owners of the particular security.
