FNB Botswana Make an eWallet on the App and Win Competition

Terms and Conditions

These rules were first published: 25 July 2022

Read these competition rules carefully. These competition rules ("rules") explain your rights and duties in connection with this competition. If you take part in this competition or accept any prize, these rules will apply to you, and you agree that FNB Botswana (herein referred to as "FNBB" "the promoter(s)" or the "Bank") can assume that you have read and have agreed to be legally bound by these competition rules.

1. The Make an eWallet on the App and Win (the "Competition") is open to FNB Retail card holders (Student, Smart, Gold, Premier, Private Clients) and Commercial-SME card holders who hold a transactional account and are in good standing with FNB Botswana, aged 18 years and above.
2. The Competition will run over a three-month period commencing at 00:00am on the 21st of August 2022 to 11:59pm on the 12th of November 2022.
3. SME and Retail customers who make eWallet payments of any amount on the FNB Banking App shall, subject to clause 4 below, be automatically entered into the Competition and shall stand a chance to win
 - one (1) of four (4) Weekly prizes of P5,000.00 eWallet Cash Prize (2 Retail and 2 SME customers)
 - one (1) of four (4) monthly prizes of P10,000.00 in Cellphone vouchers. (2 Retail and 2 SME customers)
4. There are no restrictions on the number of valid entries per Customer, a customer must make an eWallet payment of any amount as many times as desired to be eligible to participate in the competition. Every payment will be deemed to be a valid entry.
5. Participation in this Competition is free with no attendant Competition costs.
6. Potential winners shall be selected from the pool of entrants by using a randomizer tool/system during the competition. The randomizer is an excel based tool which takes the range of all qualifying entries and randomly selects one entry as the winning participant
7. The selection process of the winner(s) will be overseen by FNB Botswana internal auditors (the Judges).
8. Potential winners shall be contacted telephonically, via the telephone number registered with the Bank to inform them that they have been selected as winners.
9. Potential winners must ensure their eWallet accounts have zero balance upon selection, the cash prize is equivalent to maximum amount a wallet account can hold.
10. Weekly draws will be conducted every Thursday of the week, while monthly draws will be done on the first Thursday of the following month at FNB Head office CBD Gaborone through Microsoft Teams. The results of all draws will be publicly communicated via applicable media including SMS, radio and newspaper publications following the draw.
11. Winners must produce their valid original identification documents in the form of either their OMANG (citizens) or Passport (non-citizens), when claiming their prize (cellphone voucher) at FNB Head Office in CBD Gaborone. With regards to winners residing outside Gaborone, prizes (cellphone vouchers) will be sent to their nearest FNB Branch for collection whereas cash prizes will be sent to the winner's cellphone number registered with the bank.
12. Winners must redeem their prizes (cellphone vouchers) at any Cell City outlet countrywide.
13. Prizes won cannot be transferred to another customer.
14. The Bank reserves the right to conduct a re-draw should, for any reason whatsoever, the Initial winner is unreachable on their provided cellphone number and fails to redeem their prize after three (3) days of attempt. The Bank will attempt contact the winner daily on their provided cellphone number and/or email address provided, for three (3) consecutive working days to redeem their prize. In such circumstances, the entrants and/or initial winner for any week and/or grand prize at the time, shall irrevocably waive their rights to the prize money and/or the Grand Prize, should the Bank fail to reach them in circumstances contemplated herein.

By taking part in this competition, you give the promoter(s) a world-wide, royalty free and non-exclusive license to reproduce, modify, adapt and publish any content you have submitted to the promoter for purposes of the competition for the purpose of promoting the products and services of the promoter(s). The promoter(s) will not publish your name or photograph unless the promoter(s) have your consent to do so.

FNBB reserves the right to cancel, alter, withdraw, terminate or temporarily suspend this Competition (including these Terms and Conditions) in the event of any unforeseen circumstances or technical reasons outside its control, with no liability to any of the entrants or third parties. Should any unforeseen circumstance result in the mentioned outcomes, the public will be duly informed through SMS, radio, newspapers, social media and the Bank's official website and official letter will be sent to Gambling authority to inform them of the changes;
17. This Competition is not open to FNBB Staff, FNBB Directors, Suppliers and/or the immediate family members of the aforementioned class of persons.

IMPORTANT NOTICE: TAX IMPLICATIONS

We strongly recommend that you obtain independent professional advice regarding any tax implications arising from the receipt, transfer or spend of any prizes and/or awards obtained in respect of this Competition.

You are fully responsible for any tax implications arising from or associated with any receipt, transfer or spend of any prize/s, awards and Cash rewards due to Your participation in this Competition.

You agree that you will not hold FNBB, its Shareholders, Directors, Employees, Agents and/or Affiliates ("the Bank") liable and hereby fully indemnify the Bank, and hold the Bank completely harmless, against all damages, claims and fines made against You or the Bank by Third Parties, including all legal costs on an attorney-and-own-client scale, to the extent to which such damages, claims and fines arising out of or are connected to any taxation relating to our receipt, transfer or spend of any prize/s and/or awards or the charges in respect hereof.

GENERAL RULES THAT APPLY:

- You may not post updates that are derogatory or harmful to the Bank (i.e. the "Promoters"), or any other person. By posting any content You warrant that You are the sole creator, designer, author or owner of the work and that You have the right to post the work.

- Even though the Promoter(s) run the competition on the website the Promoter(s) do not endorse any third party, its site, its products, or services or any content on the website. You use the third party website at your own risk. You must take all necessary measures to protect yourself from risks, such as viruses and other destructive code.

- The promoter(s) can put in place such technical or other remedies it considers appropriate to prevent abuse, or to protect any sites or our systems or other users.
- You understand that this competition is not in any way being sponsored, endorsed or administered by, or associated with any social network site. You fully release the owners of those social network sites from any legal responsibility to You or any other person.

By participating in this competition, you understand that you are providing information to the Promoter(s) and not to the owners of such social network sites.

IMPORTANT:

- You agree to indemnify the promoter(s) and the Bank fully for any loss or damage the promoter(s) may suffer because you breached the competition rules. This means you agree to reimburse the promoter(s) for the following: any loss or damage they suffer, any expenses and costs they paid or are responsible for. Legal costs mean costs on an attorney and own client scale.
- You also agree to indemnify the promoter(s) for any loss or damage you suffered because you took part in this competition or used the prize. If you enter yourself, or use or accept the prize, you understand that you do so of your own free will.
