

FNB Botswana Swipe & Win Competition Terms and Conditions

for 09 September 2022 to January 31st, 2023

Read these competition rules carefully. These competition rules ("rules") explain your rights and duties in connection with this competition. If you take part in this competition or accept any prize, these rules will apply to you, and you agree that FNB Botswana (herein referred to as "FNBB" "the promoter(s)" or the "Bank") can assume that you have read and have agreed to be legally bound by these competition rules.

- 1. The Swipe and Win Competition (the "Competition") is open to all FNB Visa cardholders who hold a transactional account and are in good standing with FNB Botswana ("FNBB" or the "Bank"), aged 18 years and above.
- 2. The Competition will run for a period of five (5) months commencing at 00:00am on the 9th of September 2022 to 11:59pm 31st January 2023. The draws of this competition will end in February 2023.
- 3. Customers who swipe or tap their FNBB Visa debit or credit cards shall, subject to clause 4 below, be automatically entered into the Competition and shall stand a chance to win.
- 4. The campaign will be run in two phases, the hospitality prize, and the cash prize as follows:
- 5. Twenty-One (21) lucky customers who swipe with FNB VISA debit or credit card between 9th September and 22nd October 2022 stand a chance to draw and win weekly cash prize of up to P5 000.00 in cash or a **hospitality prize** of a fully paid for trip for two (2) to the FIFA World Cup games held in Qatar:

- 6. Potential winners shall be selected from the pool of entrants by using a randomizer tool/system every Wednesday during the competition. The randomizer is an excel based tool which takes the range of all qualifying entries and randomly selects one entry as the winning participant.
- 7. There are no restrictions on the number of valid entries per Customer, however, a customer must swipe or tap their FNB Visa debit or credit card a minimum of five (5) times per week, to be eligible to participate in the competition. Every subsequent swipe or tap thereafter will be deemed to be a valid entry.
- 8. Participation in this Competition is free with no attendant Competitioncosts.
- 9. Potential winners shall be contacted telephonically, via the telephone number registered with the Bank and invited to the weekly draw.
- 10. The selection process of the winner(s) will be overseen by FNB Botswana internal auditors (the Judges).
- 11. The date, time, and venue of the weekly Prize Draw will be publicly communicated via applicable media including SMS, radio, newspaper publication etc. prior to the draw.
