



**FNB Botswana Transact and Win Terms and Conditions effective
from 20th of July 2025 until 30th August 2025**

Read these competition rules carefully.

These Competition rules (“rules”) explain your rights and duties in connection with this competition. If you take part in this Competition or accept any prize, these rules will apply to you, and you agree that FNB Botswana (herein referred to as “FNBB” “the promoter(s)” or the “Bank”) can assume that you have read and have agreed to be legally bound by these competition rules.

1. The Transact and Win with the FNB App (the “Competition”) is open to all FNBB customers with retail accounts (Student, Smart, Gold, Premier, Private Clients) who hold a transactional account and are in good standing with FNB Botswana (“FNBB” or the “Bank”), aged 18 years and above. Winners transactional accounts must be in good standing with no overdue or defaulted payments or pending litigation at the time of the draw.
2. This Promotion will run over a six (6) week period commencing at 00:00am Sunday 20 July 2025 and ending Saturday 30 August 2025 at 23:59pm. Winners will be selected on a **weekly basis**, based on entries made from **Sunday to Saturday**. The FNB Botswana Business Intelligence team will extract and provide the relevant transaction data at the end of each week.
3. Potential winners shall be selected from the pool of entrants by using a randomizer tool/system during the competition. The randomizer is an excel based tool which takes the range of all qualifying entries and randomly selects one entry as the winning participant.
4. The selection process of the winner(s) will be overseen by FNB Botswana internal auditors (the Judges).
5. The randomizer tool will identify a total of sixty (60) qualifying customers per week, twenty (20) in each of the three (3) categories below: Each winner will be credited cash prize of five hundred pula (P500.00) into their account.

6. There are no restrictions on the number of valid entries per Customer, a customer must recharge with P100 (one hundred pula) or more as many times as desired to be eligible to participate in the competition. Every Purchase or transaction will be deemed to be a valid entry.
7. Entry in this Competition is free with no attendant Competition costs.
8. Potential winners shall be contacted telephonically, via the telephone number registered with the Bank to inform them that they have been selected as winners.
9. Prizes won cannot be transferred to another customer nor traded in for an alternative prize.
10. The Cash prizes shall be credited to the winner’s FNBB account within two (2) weeks from the date of the draw.
11. The Bank will attempt to contact the winner weekly for a period of three (3) months to redeem their prize.
12. The Bank reserves the right to conduct a re-draw should it, for any reason whatsoever, and after three (3) months of attempt to reach winners, prove futile to reach the initial winner(s) on their registered telephone number i.e cellphone and/or landline as may be duly authorized by the Gambling Authority.
13. In such circumstances, the entrants and/or initial winner for any week at the time, shall irrevocably waive their rights to the prize money, should the Bank fail to reach them in circumstances contemplated herein.
14. By taking part in this competition, you give the promoter(s) a world-wide, royalty free and non-exclusive license to reproduce, modify, adapt, and publish any content you have posted on the site for purposes of the competition for the purpose of promoting the products and services of the promoter(s).
15. FNBB will seek approval from the Gambling Authority should the need arise to cancel, alter, withdraw, terminate, or temporarily suspend this Competition (including these Terms and Conditions) in the event of any unforeseen circumstances or technical reasons outside its control, with no liability to any of the entrants or third parties.



Should any unforeseen circumstance result in the mentioned outcomes, the public will be duly informed through SMS, radio, newspapers, social media and the Bank's official website.

16. By participating, participants consent to the use of their names, images and submissions in promotional materials without any additional compensation.
17. This Competition is not open to FNBB Shareholders, Staff, Directors, Associates, Subsidiaries, Agents nor Suppliers and/or the immediate family members of the aforementioned class of persons.

IMPORTANT NOTICE: TAX IMPLICATIONS

- The Promoter(s) can put in place such technical or other remedies it considers appropriate to prevent abuse, or to protect any sites or our systems or other users.
- You understand that this competition is not in any way being sponsored, endorsed, or administered by, or



associated with any social network site. You fully release the owners of those social network sites from any legal responsibility to You or any other person.

By participating in this competition, you understand that you are providing information to the Promoter(s) and not to the owners of such social network sites.

IMPORTANT:

- **You agree to indemnify the promoter(s) and the Bank fully for any loss or damage the promoter(s) may suffer because you breached the competition rules.
