

# FNB Botswana Save & Win Competition Terms and Conditions effective from the 27<sup>th</sup> of June 2025 until the 27<sup>th</sup> of October 2025

Read these competition rules carefully.

These competition rules ("rules") explain your rights and duties in connection with this competition. If you take part in this competition or accept any prize, these rules will apply to you, and you agree that FNB Botswana (herein referred to as "FNBB" "the promoter(s)" or the "Bank") can assume that you have read and have agreed to be legally bound by these competition rules.

The Save and Win Competition (the "Competition") is open to all FNBB clients who hold an active Flexi Fixed account and are in good standing, clients aged 18 years and above. The cash prizes of up to a **total of One Million Pula only (BWP 1 000 000)**, will be won during the campaign and will be structured as below:

From 27<sup>th</sup> June 2025 until 27<sup>th</sup> October 2025 a total of Three hundred (300) lucky FNBB clients who hold active Flexi Fixed accounts, with a minimum average balance of Two Thousand Five Hundred Pula (BWP2 500) during this period, will stand a chance to win as follows:

- 1. Competition is open to all existing and potential new FNBB individual clients who are 18 years or older.
- 2. They must hold an active Flexi Fixed Account in good standing, with no pending litigation with FNBB.
- 3. The Client's other FNBB accounts MUST all be in good standing i.e. KYC compliant, No arrears & No delinquencies in the past 3 months from the draw date.
- 4. A Client may have multiple qualifying Flexi Fixed accounts. Each qualification will earn them an entry into the draw subject to the below criterions.

#### 5. Weekly Winners:

- a. A total of thirty-eight (38) lucky Clients will win One thousand pula each (BWP1,000.00) weekly when they call in and participate in Q&A quizzes on selected local radio stations. These winnings will be paid into any of their FNBB Pula accounts.
- b. A total of thirty-four (34) lucky Clients will win Five hundred Pula (BWP500) each through Facebook Quizzes, which winnings are to be paid into any of their FNBB Pula accounts.
  - i. Clients will have to answer questions on the FNBB Official Facebook page.
- 6. **Monthly Winners:** A total of seventy-eight (78) lucky Clients will each win a cash prizes of Two Thousand Five Hundred Pula (BWP 2 500). Of the 78, twenty-six (26) lucky clients will be randomly selected each month for Three (3) months and should meet the below criteria to stand a chance to win, and the prizes will be paid into the Client's FNBB Flexi Fixed Pula Account through Electronic Funds Transfer (EFT).
  - a. **Criteria:** To qualify for the monthly prize draws, clients must maintain a minimum average balance of BWP 2,500 during that specific month in their Flexi Fixed account. This will earn them an automatic entry into the draw.
  - b. Customers can increase their chances of winning by depositing at least BWP 1,000. Each deposit of BWP 1,000 or more earns 1 extra entry, up to 5 extra entries per month.
- Grand Finale: At the end of the competition, a final draw will be conducted where One Hundred and fifty (150) randomly selected lucky clients stand a chance to each win cash prizes of Five Thousand Pula Only (BWP5 000), which will be paid into the Client's FNBB Flexi Fixed Pula Account through Electronic Funds Transfer (EFT).
  - a. **Criteria:** To qualify for the grand prize draws, clients must maintain the minimum average balance of BWP 2,500 every month for the entire 4-month campaign period in their Flexi Fixed account. This will earn them an automatic entry into the draw.



- b. Customers can increase their chances of winning by depositing a minimum of BWP 2,500. Every deposit of BWP 2,500 or more gets 1 extra entry into the draw, with maximum 5 additional entry per month.
- 8. Monthly and grand finale winners will be selected randomly from a pool of entrants by using a randomiser tool/system. The randomiser is an excel based tool which takes the range of all qualifying entries and randomly selects one (1) entry as the winning participant.

## Other Competition Terms and Conditions

- 10. Participation in this Competition is free with no attendant costs. There shall be no fees due from finalists who have been invited to the draw.
- 11. The selection process of the winner(s) will be overseen by FNB Botswana internal auditors (the Judges).
- 12. Winners shall be contacted telephonically, via the telephone number registered with the Bank.
- 13. The date, time, and venue of the Prize Draws will be publicly communicated via applicable media including SMS, radio, social media etc. prior to thedraw.
- 14. Winners must produce valid original identification documents in the form of either their OMANG (citizens) or Passport (non-citizens), when claiming their cash prize.
- 15. Prizes won cannot be exchanged and/or returned and neither are they negotiable nor transferable.
- 16. The Cash prizes shall be credited to the winner's FNBB account within three (3) weeks from the date of the draw.
- 17. The Bank will attempt to contact the winner weekly for a period of three (3) months to redeem their prize.
- The Bank reserves the right to conduct a re-draw should it, for any reason whatsoever, and after three
  (3) months of attempts to reach winners, prove futile to reach the initial winner(s) on their telephone number i.e., Cellphone and/or land line.
- 19. In such circumstances, the entrants and/or initial winner for any week and/or grand prize at the time, shall irrevocably waive their rights to the prize money and/or the Grand Prize, should the Bank fail to reach them in circumstances contemplated herein.
- 20. By taking part in this competition draw, you give the promoter(s) a world-wide, royalty free and nonexclusive license to reproduce, modify, adapt, and publish any content you have posted on the site for purposes of the competition for the purpose of promoting the products and services of the promoter(s).

FNBB will seek approval from the Gambling Authority should the need arise to cancel, alter, withdraw, terminate, or temporarily suspend this Competition (including these Terms and Conditions) in the event of any unforeseen circumstances or technical reasons outside its control, with no liability to any of the



entrants or third parties. Should any unforeseen circumstance result in the mentioned outcomes, the public will be duly informed through SMS, radio, newspapers, social media and the Bank's official website.

- 22. This Competition is not open to FNBB Shareholders, Staff, Directors, Associates, Subsidiaries, Agents nor Suppliers and/or the immediate family members of the aforementioned class of persons.
- 23. Competition participants shall be able to view the updated Terms and Conditions on the FNBB website.

By participating in this competition, you understand that you are providing information to the Promoter(s) and not to the owners of such social network sites.

# **IMPORTANT:**

- You agree to indemnify the promoter(s) and the Bank fully for any loss or damage the promoter(s) may suffer because you breached the competition rules. This means you agree to reimburse the promoter(s) for the following: any loss or damage they suffer, any expenses and costs they paid or are responsible for. Legal costs mean costs on an attorney and own client scale.
