

#### "Win Back 3 Repayments Campaign" Home Loans

Read these competition rules ("Rules") carefully. The rules explain your rights and duties under this competition. Consequently, if you take part in this competition and/or accept any prize pursuant to the competition, these rules will apply to you. Accordingly, you agree that the person running this competition ("the promoter/s") can validly proceed on the understanding that you have read, understood and agree to be legally bound by these Rules.

- 1. The Home Loans Competition (the "Competition") is open to all individuals (i.e. both FNB and non-FNB banked Customers) aged 21 years and above who successfully apply for (i.e. are granted) a new property loan of not less than BWP 100 000.00 or a top-up loan (i.e. on an existing mortgage facility) of BWP 75 000.00 or more, over the duration of the Competition ("Participating Customers") with FNB Botswana ("FNBB" or the "Bank") and are aged 21 years and above;
- The Competition will run over a six-month period commencing at 00:00am on the 13<sup>th</sup> of February 2019 to 11:59pm on the 31<sup>st</sup> July 2019;
- 3. All Participating Customers shall automatically be entered into the Competition upon meeting the qualifying criteria. Each month- for the duration of the Competition, one lucky Customer shall win a shopping voucher valued at BWP 1000.00.
- 4. At the end of the Competition, two (2) Customers shall win the ultimate Grand Prize of cashback rewards valued at the equivalent of three (3) months loan instalment payments for the selected Customers, provided that cumulatively, same does not exceed the sum of BWP 30 000.00 (i.e. is capped at a total of BWP 30 000.00 per winner);
- 5. Participation in this Competition is free with no entry fee;
- 6. There are no restrictions on the number of times Participants can enter the Competition. Thus, each qualifying customer can enter the Competition as many times as reasonably practicable; Entries are limited to one entry for meeting the above criteria
- 7. Winners will be randomly drawn from a pool of all entrants and shall be notified telephonically, via the telephone number registered with the Bank;
- 8. The Grand Prize Draw will take place on the 30<sup>th</sup> August 2019 at 11am at FNBB offices in the presence of FNBB Internal auditors;
- 9. Winners must produce valid original identification documents in the form of either their OMANG (citizens) or Passport (non-citizens), when claiming their prize;
- 10. Prizes won cannot be exchanged or returned and neither are they negotiable nor transferable;
- 11. All risk in and to the Competition Prizes (inclusive of the Grand Prize) shall automatically pass onto the winner immediately upon transfer of the prize to the winner. Thereafter, the winner



shall be solely liable (and responsible) for any and all risks associated with ownership of the prize, including the risk of loss and/or damage to the Prize;

Accordingly, the winning customer(s)' fully indemnify, including all legal costs on an attorney and own client scale, FNBB, its shareholders, affiliates, directors, employees and/or agents, against any demands and/or claims raised by the winners, their assignees or successors in title, relative to damage and/or losses sustained by them, as contemplated herein;
- 13. The Bank reserves the right to conduct a re-draw should it, for any reason whatsoever, and after three (3) attempts prove futile to reach the initial winner on their telephone number. In such circumstances, the entrants irrevocably waive their rights to prize money and/or the grand prize, should the Bank fail to reach them in circumstances contemplated herein;
- 14. FNBB reserves the right to use the winners' names, surnames, pictures and winnings ("Customer details") for Marketing purposes including but not limited to newspapers, radio, TV, social media. The exercise of this right shall, however, be conditional upon the winners' consent. FNBB shall not publish the winners' details without the winners' prior written consent. In the event that the winner agrees to their details being used by the Bank as envisaged herein (i.e. for marketing purposes), the winners shall not be entitled to any remuneration and accordingly waive any rights to such entitlement;

FNBB reserves the right to cancel, alter, withdraw, terminate or temporarily suspend this Competition (including these Terms and Conditions) in the event of any unforeseen circumstances or technical reasons outside its control, with no liability to any of the entrants or third parties. Should any unforeseen circumstance result in the mentioned outcomes, the public will be duly informed through SMS, radio, newspapers, social media and the Bank's official website;
- 16. This Competition is not open to FNBB Staff, FNBB Directors, Suppliers and/or the immediate family members of the aforementioned class of persons;
